



In 2010 GYLA with financial support of the German Foundation for International Legal Cooperation announced another competition for participating in the Olympiad.


100 groups from different universities of Georgia expressed their interest to participate in the Olympiad.



8 groups were selected on the basis of the lawsuit

and counterclaim prepared in frames of the casus that had been proposed in advance.

The Olympiad in the field of constitutional law was traditionally held in Batumi on



December 10-11, where the selected

groups participated.


The trials were administered in rather interesting manner and evaluate by judges both Georgian and European.

The judges also acted as the jury, guiding the imitated trials.


Semi-finalists were identified on the first day, while finalists were determined on the

The team of Iv .Javakhishvili Tbilisi State University


and its members Giogi Javakhadze, Tornike Tsitsilashvili and Ilia Eliadze was the second finalist.

Giorgi Javakhadze was named as the best plaintiff of the Olympiad, while Tamar Karazishvili won the title of the best defendant.

Levan Maisuradze was named as the Constitutional Court's favorite participant, while Giorgi Javakhadze - the finalist and the best plaintiff of the Olympiad - received the title of the IRZ Foundation's favorite participant. He received a one-week trip to






foundation, in order to visit courts and other official

At the closing ceremony the students were awarded with certificates by GYLA Chairperson Tamar Chugoshvili and Chairman of the Constitutional Court of Georgia Giorgi Papuashvili.
